Make sure to request the "IRS Tax Return Transcript" and *NOT* the "IRS Tax Account Transcript." (*Unless* you have amended your return, then you will need both the Account and Return transcripts).
- <u>Get Transcript ONLINE</u> Go to <u>irs.gov</u>, click "Get Your Tax Record." Click "Get Transcript ONLINE." Make sure to request the "IRS Tax Return Transcript" and *NOT* the "IRS Tax Account Transcript." (*Unless* you have amended your return, then you will need both the Account and Return transcripts).

- Paper Request Form IRS Form 4506T-EZ or IRS Form 4506-T

If the student and spouse filed separate 2021 IRS income tax returns, **2021 IRS Tax Return Transcripts or a signed copy of the 2021 income tax return and applicable schedules** must be provided for both.
