	CALL TO ORDER:	A special meeting of the Northwest College Board of Trustees was held Friday, February 8, 2013, at 1:30 p.m. in the DSC Trapper Room.
A	APPROVE THE AGENDA:	A motion was made by Trustee Danko and seconded by Trustee Fees to approve the agenda as presented. Motion carried.
Α	SELECTION OF NEW PRESIDENT AND CONTRACT APPROVAL:	Board President Westerhold reported that Northwest College had three exceptional presidential candidate finalists; however, the majority of the feedback had strong support for Dr. Stefani Hicswa. She has the background, education and leadership skills necessary to lead the College. Dr. Hicswa's contract will begin July 15, 2013 and go through July 1, 2015. The salary is \$162,000 plus campus housing for up to one year after which she will receive a housing allowance of \$1,000 per month. Contract renewals, extensions and negotiations are prescribed for May each year. Further details are included in the contract. Final signing of the contract will be completed upon a satisfactory background check.
		A motion was made by Trustee Vogt and seconded by Trustee Larsen to offer Dr. Stefani Hicswa a two-year contract as described. Motion carried.
	OTHER BUSINESS:	An interim president will be appointed for the gap between June 30 <sup>th</sup> when President Prestwich's contract ends and the beginning of Dr. Hicswa's contract on July 15 <sup>th</sup> . The appointment will be made at the May or June Board meeting.
