CALL TO ORDER:	The budget hearing of the Northwest College Board of Trustees convened on Monday, July 12, 2021, at 4:07 p.m. via Zoom.
REVIEW FISCAL YEAR 2022 BUDGET:	Interim President Watson stated this is the second reading of the FY22 Budget, which will be finalized today in order to meet statutory requirements.
	Interim President Watson directed Trustees to a memo on page 7 of the Budget Book which outlines the budget as previously discussed. The only change is indicated in the fourth bullet point on page 8, which reads: "Employer Retirement Contribution 3% Transfer to Employees – The Board of Trustees voted in April 2021 to transfer 3% of the employer retirement contribution to the employee. Since April 2021, multiple Park County government agencies have voted to provide employee raises. Due to one-time only true up of budget to actual insurance costs, the College instituted a temporary hold on transferring the 3% employer contribution to the employee for FY 2022. This temporary hold will assist in retention and inflationary considerations."
	Interim President Watson also noted the local levy appropriations had been estimated at approximately \$629 million previously; however, final numbers from Park County came in at \$626 million. Final local levy values are still being reconciled by the Wyoming Community College Commission. If there is a shortage after final numbers are known, the College will seek a budget amendment.
